

Programme Contents

1st Year

Students acquire basic business knowledge and skills, including **Accounting, Personal Finance, Management and Marketing**.









2nd year to 4th year

Students proceed to study more in-depth theories and practical examples from the operational and organizational perspectives in each Major Core Area, such as Financial and Management Accounting, Human Resources and Small Business Management, Financial Management, Legal and Ethical Issues, and Technology in Business and Creativity, and "Investment" or "Strategic Management".

3rd Year

A 7-week **teaching practice** in secondary school.



5th Year

The **Final Year Project** allows students the opportunity to explore areas of interest in a more independent and self-directed mode and a 7-week **teaching practice** in secondary school.

Field Experience (FE)

Students will be placed in schools which are important sites for their learning on how to **teach** and where they will **interpret**, **generate**, **interact and experiment with theory**.





Field Experience (20 cps)

Different phases:

- 1. Year 2 Sem I & Sem II
 - FE Foundation Course (3 cps)
- 2. Year 3 Sem II
 - Block Practice I (5 cps); and
 - FE and Professional Learning Portfolio I (2 cps)
- Year 5 Sem I
 - Block Practice II (7 cps); and
 - FE and Professional Learning Portfolio II (3 cps)

Field Experience and Experiential Learning Semester (GAR 9.10.4)

Students should complete a minimum of 7 credit points in each Field Experience and Experiential Learning Semester
(for students admitted in 2019/20 and hereafter). Students shall only take Field Experience and/or Experiential
Learning Courses (including Co-curricular and Service Learning courses and Experiential Learning courses) and Honours
Project / Capstone Project / University ePortfolio, but not other regular taught courses in the Field Experience and
Experiential Learning Semester.



Cross-Faculty Core Course (CFCC)

- The Cross-Faculty Core Course (CFCC) will comprise 3 individual components with 1 credit point each and separately assessed with the aim to widen students' horizon and look beyond Hong Kong.
- Component I: Lectures with topics related to Basic Law / National Security
- Component II: Visits in Greater Bay Area#
- Component III: A variety of themes which are linked to the University's development niche areas

Students admitted into this programme starting from the 2023/24 cohort are required to visit the Greater Bay Area (GBA) and/or other parts of Mainland China. Programme may also require students to participate in other non-local learning experience for completion of the programme. While the visits are heavily subsidised, students are still required to contribute part of the estimated cost of the visits ("student contribution"), whereas personal entertainment, meals expenses, travel document fee and personal insurance costs will not be supported. The estimated cost of the visits for students admitted to the 2024/25 cohort is not available yet as it is subject to a variety of factors such as changes to the cost of the visits as a result of inflation, trip duration, traveling expenses, the exchange rate, etc. The exact amount of student contribution is thus not available.
